WAC 388-76-10025 License annual fee.

- (1) The adult family home must pay the license fee that is established in the state's operating budget, as described in RCW 70.128.060 .
- (2) Each year, the home's annual license fee is due during the same month in which the home was initially licensed. For example, if the home was licensed in June, 2010, then the annual licensing fee will be due in June of each year.
- (3) The home must ensure that the department receives the annual license fee when it is due.
- (4) If the home does not pay the fee when it is due, the department will impose remedies.

This requirement was not met as evidenced by:

Based on observation, interview and record review, the Adult Family Home (AFH) failed to pay their License annual fee when it was due. This failure resulted in the AFH operating without a valid license since 02/15/2024 and placed all residents at risk of losing their home.

Findings included...

Review of the AFH financial information in the department's "Secured Tracking and Reporting System" on 04/15/2024, showed the annual license fee was due on 02/15/2024. This had not been paid.

In an unannounced visit on 04/15/2024 at 3:30 PM, observed five Residents (Residents 1, 2, 3, 4, and 5) resided and received care in the AFH.

In an interview on 04/15/2024 at 3:45 PM, Staff A, Entity Representative stated that they mailed a check to the department, the address was wrong, and the check was returned to them. Staff A confirmed that they had not paid their annual license fees.

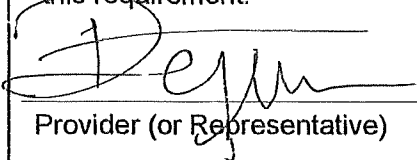
