WAC 388-76-10510 Resident rights Basic rights. The adult family home must ensure that each resident:

(4) Has the opportunity to exercise control over life decisions, such as making the resident's own choices about daily life, participation in services or activities, care, and privacy;

This requirement was not met as evidenced by:

Based on interview and record review, the adult family home (AFH) failed to ensure 1 of 3 residents (Resident 1 [R1]) maintained the right to exercise control over their life decisions. This failure resulted in R1 not being able to leave the AFH when they desired.

Findings included...

Review of R1's record, titled "Assessment", dated 5/6/2024, showed they had a [REDACTED] dog.

On 2/04/2025 at 1:23 PM, R1 stated they had a [REDACTED] dog and was told by the AFH staff that they were not able to leave the AFH before 8 AM or after 8 PM to allow their dog to go to the bathroom outside or have a cigarette after 8 PM. *- 3/10/2025 will be corrected per WAC by then.*

Review of AFH record, titled "WE & E Smoking rules", dated 5/5/2024 showed R1 was not permitted to go out to meet friends at night and that R1's [REDACTED] dog can be taken outside of the AFH from 5 AM to 8 PM and "failure to comply with this rule can lead to discharge from WE & E AFH". Record also showed R1 was allowed to smoke from 8 AM to 8 PM and that smoking at night may also result in discharge from the AFH. *- 3/10/2025 will be corrected by then*
