This letter addresses deficiencies occurring in the report(s) for: Compliance Determination(s) 53563 (Completion Date 01/24/2025) and 52144 (Completion Date 12/23/2024).

The Department completed a follow-up inspection of your Adult Family Home on 01/24/2025 and found no deficiencies.

The Department found that deficiencies for the following licensing laws and regulations were corrected:

WAC 388-76-10025 License annual fee.

- (1) The adult family home must pay the license fee that is established in the state's operating budget, as described in RCW 70.128.060 .
- (2) Each year, the home's annual license fee is due during the same month in which the home was initially licensed. For example, if the home was licensed in June, 2010, then the annual licensing fee will be due in June of each year.

This requirement was not met as evidenced by:

Based on observation, interview, and record review, the Adult Family Home (AFH) failed to ensure the annual licensing fee was paid as required to maintain a valid license for 6 of 6 residents (Residents 1, 2, 3, 4, 5, and 6) residing in the AFH. This failure resulted in residents living in an AFH with outstanding licensing fees.

Findings included...

On 12/23/2024 review of Secure Tracking and Reporting System (STARS) showed the AFH's annual licensing fee of \$1,350.00 was due on 10/15/2024 and had not been paid.

On 12/23/2024 at 10:26 AM observation showed Residents 1, 2, 3, 4, 5, and 6 resided in the home and received care and services from AFH staff.

On 12/23/2024 at 10:26 AM, Staff A, Provider, stated they had not paid the annual licensing fee.
