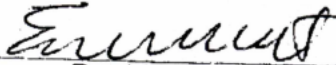

Based on interview and record review the Adult Family Home (AFH) failed to contact the Department Hotline when 1 of 1 resident (Resident 1) went missing. This failure placed Resident 1's safety at risk and a delay in the investigation.

Findings included...

Record review showed the AFH admitted Resident 1 on [REDACTED]/2023.

Record review of Resident 1's progress notes, dated [REDACTED]/2023, showed that Resident 1 left the home upon arrival to the AFH and did not return. The progress notes showed that Staff A (Provider) contacted Emergency Services, Resident 1 was located and taken to a local hospital.

Record review of Resident 1's progress notes, [REDACTED] 2023, showed that Resident 1 returned to the home on [REDACTED]/2023 and left the AFH again on [REDACTED]/2023. The progress notes showed that Staff A contacted Emergency Services at that time. Resident 1 was located and admitted to the hospital.

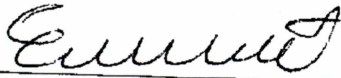
In an interview on 10/10/2023 at 1:20 PM, Staff A stated that she was not sure if it needed to be reported to the hotline.
