(1) A Washington state name and date of birth background check is valid for two years from the initial date it is conducted. The adult family home must ensure:

(a) A new DSHS background authorization form is submitted to the department's background check central unit every two years for each individual listed in WAC 388-76-10161 ;

This requirement was not met as evidenced by:

Based on observation, interviews and record reviews, the Adult Family Home (AFH) failed to ensure there was a valid Washington state name and date of birth (WDOB) background check renewed every two years for 1 of 4 staff (Staff A, Provider). This failure placed residents at risk of potential harm from staff with an unknown background.

Findings included...

In an observation on 08/28/2025 at 11:50 AM, Residents 2, 4 and 5 were sitting down at the dining room table eating their lunch.

In an interview with Staff D, Co-Provider, on 08/28/2025 at 1:45 PM, review of the AFH summary showed the AFH was licensed on 07/06/2023.

On 08/28/2025, a record review of Staff A's personnel file showed Staff A's WDOB background check expired on 02/14/2025. Another WDOB background check found in

the personnel records for Staff A showed it was completed on 08/24/2025, expiring 08/24/2027.

In an interview with Staff D at 2:02 PM on 08/28/2025; they stated that Staff A must have forgotten to renew the WND0B background check when Department Staff asked why the delay of six months and ten days to renew.

In a telephone interview on 08/29/2025 at 2:28 PM, Staff A stated that they thought the expiration date of the WND0B background check coincided with the AFH licensing date which is why it was completed in August 2025.

I hereby certify that I have reviewed this report and have taken or will take active measures to correct this deficiency. By taking this action, Addis Angels AFH (AAA), LLC is or will be in compliance with this law and / or regulation on (Date)_____.
