WAC 388-76-10025 License annual fee.

- (1) The adult family home must pay the license fee that is established in the state's operating budget, as described in RCW 70.128.060 .
- (2) Each year, the home's annual license fee is due during the same month in which the home was initially licensed. For example, if the home was licensed in June, 2010, then the annual licensing fee will be due in June of each year.
- (3) The home must ensure that the department receives the annual license fee when it is due.
- (4) If the home does not pay the fee when it is due, the department will impose remedies.

This requirement was not met as evidenced by:

Based on observation, interview and record review, the Adult Family Home (AFH) failed to ensure the annual licensing fee was paid as required to maintain a valid license for 5 of 5 residents (Residents 1, 2, 3, 4, 5). This failure resulted in residents living in an AFH with outstanding licensing fees.

Findings included...

On 01/16/2025 review of Secure Tracking and Reporting System (STARS) showed the AFH's annual licensing fee of \$1,350.00 was due on 11/15/2024 and had not been paid.

On 01/16/2024 at 10:25 AM observation showed Residents 1, 2, 3, 4, & 5 required care and services from AFH staff.

On 01/16/2025 at 3:45 PM Staff A, Provider, stated they had forgotten to pay their annual licensing fee.
