WAC 388-76-10360 Negotiated care plan Timing of development Required. The adult family home must ensure the negotiated care plan is developed and completed within thirty days of the resident's admission.

This requirement was not met as evidenced by:

Based on interview and record review, the adult family home (AFH) failed to complete Negotiated Care Plans (NCP) within thirty days of admission for 2 of 5 residents (Resident 4 [R4] and Resident 5 [R5]). This failure placed R4 and R5 at risk of not having their assessed care needs met.

Findings included...

The deficiency was corrected on 5/17/2025. We shall be compliant to the laws at all times. - Sherryat Susan Lasiamon 5/20/2025

During an interview on 05/06/2025 at 11:34 AM, the Provider stated that R4 admitted to the AFH on [REDACTED]/2025 and R5 admitted to the AFH on [REDACTED]/2025.

During a record review on 05/06/2025 at 11:24 AM, the AFH could not provide a NCP for R4 or for R5 when requested.

During an interview on 05/06/2025 at 11:34 AM, the Provider stated that R4 and R5's NCP's were not finished and Caregiver A (CGA) was working on them.

During an interview on 05/06/2025 at 11:44 AM, CGA stated that they had not completed R4 or R5's NCPs and did not have anything to show the department.

A record review on 05/06/2025 at 11:33 AM of R4's Admission Agreement showed that
