On February 26, 2025 an inspection was completed at Bonaventure of East Wenatchee at 50 29th Street NW in Wenatchee, Washington. The complaint received was in regard to excessive storage conditions within resident room #466, potentially causing a life safety issue to the resident, visitors, and occupants of the facility.

A visit was made with the resident (with the assistance of nursing staff) who was relocated to an adjacent room due to quarantine conditions in Room 466. The resident was open to discussion regarding fire and life safety and health to themselves, other residents within the facility, and first responders. Education was given to the resident regarding adequate access and egress spaces in the event of an emergency, and the risk of excessive fire load creating unsafe conditions. Upon exiting, the Executive Director stated that a legal guardian would be assisting in the compliance process over the next thirty days.

2 Storage

Storage of combustible rubbish shall not produce conditions that will create a nuisance or a hazard to the public health, safety or welfare.

(IFC 304.2 2021)

The following violation was observed:

In Room 466 there was a significant amount of storage which consisted of combustible items in boxes and unstable piles, approximately 12" to 48" in height. The room also contained rubbish, perishable food waste, and empty glass containers lining the doorway to the bedroom from the kitchen area. Aisle ways to the bedroom and bed were obstructed by storage, and the majority of the living room area from the kitchen to the window was inaccessible.

Corrected; Upon post inspection the room was cleared of debris, garbage, and minimal storage remained in the living area and bedroom.

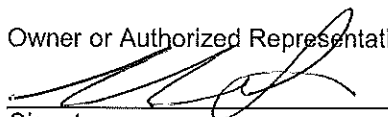
