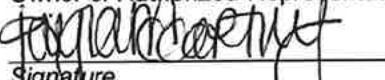
On October 9, 2025 and inspection was completed at Hearthstone Senior Living located at 802 E. Mountain View Avenue in Ellensburg, Washington for a planned fire sprinkler system outage for repairs. The fire suppression system was inspected on September 2, 2025 by the maintenance manager and it was reported that there were leaks in three separate areas of piping, and the system failed the 3-year dry trip testing. The contractor came to complete repairs on October 2, 2025 and October 8, 2025 in which fire watches were conducted for each planned repair.

Fire watch documentation was reviewed on site and were conducted in 15-minute increments from 0845 hours to 1530 hours on October 2, 2025 and from 1000 hours to 1330 hours on October 8, 2025 until the system was returned to service. There was no response from the fire department, no damage or system activations, and no residents were evacuated, harmed, or relocated due to the system repair. The facility self-reported the planned maintenance and documentation of repairs was reviewed on site.

Next inspection scheduled on or after:
