Yes, No	ON 10/1/2025, DSFM Van Gorkum entered Hillside Assisted Living located at 112 KENNEBECK AVE N, KENT, WA, 98030 investigate complaint ref # 195230. What was Reported: On 9/15/2025 to 9/18/2025 a full licensing inspection was conducted with DSHS. It was observed by the inspect that an ash receptacle was placed approximately nine feet away from the dining room entrance. Cigarette butts and ashes were on the ground. There was no sign indicating that the area was for smoking. Observations on 09/16, 09/17 and 09/18/2025 showed two to four residents smoking within the area. Smoking residents stated the area was designated for smoking. What I Observed: On 10/1/2025 at 1430, I made contact with the facility's executive director and facility maintenance director to discuss complaint investigation 195230. Through conversation I was told about what was observed during 9/15/2025 to 9/18/2025 inspection and what the facility has done since that time. While I walked with the facility maintenance director, I observed four residents smoking where the facility has made as the designated smoking area on the property. I also observed the new signage showing where the designated smoking is. I have reached out to Kent Fire Marshal's Office that has Authority Having Jurisdiction for this location and discussed the concerns I had regarding the designated smoking area that the assistant living has made for residents. No injuries were reports. No IFC violations observed.
