Yes, No	ON 03/17/2026, DSFM Van Gorkum entered Village Green Senior Living of west Seattle located at 2615 SW Barton St Seattle, Washington 98126 to investigate complaint ref # 216395. What happened: On 03/14/2026 at approximately 2:00 pm fire in resident's bathroom. Bathroom fan overheated causing a fire around the fan, which dropped plastic on the floor scorching the floor. Sprinkler in bathroom was initiated, therefore causing residents apartment to flood. Fire department came and put the fire out; water restoration came and cleaned water. We were on Fire watch for approximately 4 hours until our sprinkler company arrived to replace the sprinkler head. Resident was not in the apartment at the time of the incident. Resident is relocated to a Respite apartment until his apartment is repaired and ready for him to move back in. No injuries were reports. Local fire department responded. Fire department checked the fire and secured the sprinkler system. The facility's sprinkler vendor arrived and replaced the sprinkler and put the system in normal statis. No IFC violations observed.
