The notice indicated if the biennial report and license fee were not received by 04/30/2022, the Division of Quality Assurance will proceed with enforcement action, which may include license revocation. On 11/04/2022, the department received a confirmation of delivery. On 11/27/2023, at 2:00 PM, License Permit Program Associate - Senior C interviewed Licensee B to inquire about the status of the biennial report and fee. Licensee B stated s/he would send in their biennial report and payment as soon as possible.
