Dietetic Services 1. (a)(i) If the qualified supervisor is not a Registered Dietitian, s/he shall be a graduate of a dietetic technician program approved by the American Dietetic Association or a dietary managers' educational program approved by the Certifying Board for Dietary Managers. Training and experience in food service supervision and nutrition equivalent in content to the approved educational programs are acceptable. This standard was not met as evidenced by: Based on staff interview and review of enrollment information, the facility failed to ensure the minimum qualifications were met for the dietary manager. The findings were: Interview with the dietary supervisor on 5/22/13 at 10 AM revealed she did not meet the requirement for being a certified dietary manager. She had accepted the position recently and was enrolled in a certification program on 5/19/13. Interview with the registered dietitian on 5/21/13 at 10:16 AM verified the enrollment and he stated the course was a year long. Review of an email confirmation showed the dietary supervisor was enrolled into the University of North Dakota "Nutrition & Foodservice Professional Training Program."	SNH	Section 11. Dietetic Services Corrective Action: Current dietary manager is enrolled in dietary managers certification course through the University of North Dakota. Identification of others: All residents needing the services of a certified dietary manager may be affected. System/Measures: Current dietary manager will complete dietary managers certification course. Course will be completed by 12/31/2013. Monitor: Registered dietitian will provide monthly updates and status checks to ensure a successful completion by 12/31/2013.
